Tau Kappa Epsilon	9/12/2024; 9/5/2024	<p><u>Description of Violation:</u> A Susquehanna University student reported that they were made aware that during the professional interview night recruitment event hosted by Tau Kappa Epsilon that chapter members were asking inappropriate questions, some of which has overtones of a sexual nature. NOTE: no drug or alcohol use was involved.</p> <p><u>Result of Investigation:</u> On 9/13/2024 and 9/16/2024 Student Life and Leadership &amp; Engagement staff members investigated the allegation by individually interviewing multiple students including chapter leadership and potential new members. Students had similar accounts of the event including acknowledging the interview process at the event, including the arrangement of the chapter members being seated around the potential new members, the unscripted question asking of potential new members by chapter members, and the asking an inappropriate question to a few potential new members to have occurred. As a result of the interviews the chapter was charged with Violating the Anti-Hazing Policy (outlined in the Student Handbook).</p> <p><u>Penalties Imposed:</u> Chapter leadership took responsibility for the charge and the sanction of Disciplinary Warning was issued. The chapter was permitted to address the one individual member who asked the inappropriate questions internally and was required to provide the outcome of their internal standards procedure to the Student Life office; these internal sanctions included limiting social privileges for four weeks and the completion of five Tau Kappa Epsilon anti-hazing and new member education educational videos (content provided by the national organization) by that individual. Tau Kappa Epsilon	2/13/2023	<p><u>Description of Violation:</u> A Susquehanna University student reported an allegation of possible hazing during a recruitment event for potential new members including uncomfortable conditions and concerning questions during an interview process.</p> <p><u>Result of Investigation:</u> Campus Safety in partnership with Student Life interviewed multiple students including chapter leadership and potential new members. Students had similar accounts of the event including acknowledging the interview process at the event, awkward ambient lighting directed at the potential new members, asking an inappropriate question to a few potential new members, and logistical organization of the event that led to some potential new members waiting multiple hours for their interview to begin. As a result of the interviews the chapter was charged with Violating the Anti-Hazing Policy (outlined in the Student Handbook).</p> <p><u>Penalties Imposed:</u> Chapter leadership took responsibility for the charge and the sanction of Disciplinary Probation from February 22, 2023 through April 14, 2023 and educational sanctions were imposed.</p>	2/22/2023	5/5/2023
